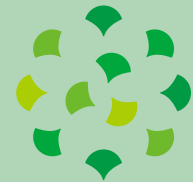
The series of “black swan events” that took place in 2016 reminded us that countries both in the East and West are faced with difficult choices. While we are astonished by the complexity and diversity of the social problems we face, we are further distressed by the lack of effective methods to initiate dialogue and reaching consensus. We fear the world is in danger of further fragmentation.

In this dismantling process, we come to the realization that most social problems, such as those relating to globalization, public education reform, and environmental protection, may not be solved by a single piece of new technology, policy or project. Ginkgo Fellow Program

The Ginkgo Fellow Program (below as Program) is a long-term investment program in human capital in the nonprofit sector. The Program invests in young social entrepreneurs, helping them achieve greater personal and career breakthroughs. Our Fellows include NGO founders and leaders, as well as promising individuals from media, academia, and related sectors.

To address the common difficulties faced by social entrepreneurs, the Program offers each Fellow a grant of RMB100,000 per year for 3 consecutive years, and also supports their professional development through biannual networking workshops and overseas learning expeditions.

Since 2010, the program has supported 98 Fellows from 22 provinces. They work in 11 different fields, including education, environmental protection, public health and rural development. Fellows learn from each other in an equal, respectful, and open-minded environment, expanding their horizons and improving their professional skills.

In-depth investigation

April through September, the preliminary selection panel conducted extensive background investigations on 157 candidates. Twenty-nine candidates were selected for further in-depth onsite interviews, and 17 of them were recommended to the expert panel for final review.

Final expert panel review

In November, the final review was held in Beijing, where a panel of 9 experts and 17 final candidates met face-to-face. In the end, all 17 candidates were selected to become the Ginkgo Fellows class of 2016. The 9 members of the expert panel are Ying Wang, Dun Li, Shouli Zhang, Haiguang Wang, Xiaojin Gu, Dongmei Xu, Yongping He, Dequan Lu, and Lanying Zhang.

Community building

In addition to receiving the 100,000 RMB grant per year for 3 consecutive years, Ginkgo Fellows also benefit from being a part of an inclusive and collaborative community. The community holds a series of events annually, including spring retreat, annual conference, overseas learning expeditions, and a Fellow Collaboration Fund.

The intent of the spring retreat is to promote friendship, collaboration, and a sense of community among the Fellows. Between March 13th -17th, 2016, spring retreat was held in Chengdu. Activities during the retreat included a welcome party for new Fellows and a series of practical workshops and experience sharing talks. A total of 43 Fellows participated in the organization of the retreat along side the secretariat team, showing a high level of community involvement.

Community building

Overseas learning expeditions

Overseas learning expedition is the most anticipated community activity each year. The Fellows return from these expeditions with broadened horizons, new perspectives and connections for global collaborations.

With funding from Xinhe Foundation, 14 Ginkgo Fellows took a self-organized expedition to Kenya from July 9th -19th. With a focus on poverty relief, the Fellows visited 14 local social enterprises and NGOs, including Greenchair, M-copa, Kazuri, Ashoka, Amani Institute, Maasai Girl Rights Foundation, and Mathare. The Fellows were deeply motivated by the level of commitment these organizations had shown towards their respective social causes.

Ginkgo Annual Conference

November 12th -13th 2016, 180 participants, including Ginkgo Fellows, their team members, Grit Youths and guests joined the Beijing for the second Ginkgo Annual Conference. The theme for the Conference was "Take Social Responsibility and Embrace Co-creation Age". An expert panel selected 17 new Ginkgo Fellows. Participants held a number of discussions on three pressing topics in social development, including youth empowerment, urban-rural relationships, and the boundary between non-profit and for-profit organizations.

Community building

Launched and funded by Ginkgo Fellows in 2015, the Collaboration Fund is geared towards promoting increased cooperation between Fellows to achieve collective impact on a shared social goal. The rules, stipulations, and disbursement of the fund are all set and managed by the Ginkgo Fellows. A group of 5 was elected from the Fellows to run and manage the fund, their responsibilities including recruitment of candidates, revising existing regulations, and supervising the grant-making process.

The Collaboration Fund was highly popular among Fellows in 2016. In the spring and fall term, 78 Fellows submitted for proposals to fund a total of 22 collaborative projects. After a collective voting process, 12 projects were selected, and a total grant given amounted 433,773 RMB, involving 63 Fellows. Compared to the grants given in 2015, not only the number of proposals increased significantly, the breadth of the proposed projects also showed significant increase, including those involving research and innovation. Moreover, as of 2016, the Collaboration Fund Work Group has served for the third term, and this team had shown notable improvement in management and cooperation.

Ginkgo Photo Story Project

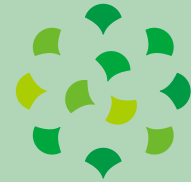
In 2016, Ginkgo Foundation supported 5 Ginkgo Fellows in raising public awareness and advocacy through a Photo Story Project. A number of renowned expert journalists supported the project as volunteer photographers, including photojournalism director for Getty Images in Greater China region Mr. Shendun Wang, previous image director from NF Media Ms. Min Qiu, and photojournalist from Tencent News Mr. YicengChe.

The Ginkgo Photo Story Project formed long-term partnerships with Tencent News, Beijing Top Result Metro Advertising Company, and TiHE Communication. Through the support from these media partners, the public is able to access the photo stories from the 5 Ginkgo Fellows on their cellphones, and in Metro stations and movie theatres nation-wide. Direct donations to relevant initiatives can also be made via the Project.

You-Talent Program

Given the dearth of talent and resources in the philanthropic sector, coupled with a lack of fundraising and development coursework at Chinese universities, the Ginkgo “You-Talent” Program helps social organizations recruit and cultivate talented professionals interested in social sector careers, particularly with regards to communication and fundraising.

The Program offers RMB 100,000 per year for 3 consecutive years to selected Ginkgo Fellow organizations to hire full time staff for fundraising, communication, research , or other key positions. In 2016, 8 additional organizations joined the Program, and the total number of organizations benefiting from this Program rose to 23.

Co-Xing Project

In 2016, You-Talent Program developed “Co-Xing Project”with an expert management advisor. Six organizations joined the Project and the core members of their team received training and one-on-one mentorship in leadership and organizational development.

In June, October and December of 2016, the Project held 6 day training events in Beijing and Hefei. Members used tools for reflection, role analysis, and culture establishment to share and reflect on the challenges they each faced. The 6 organizations that joined this Program also gained the benefit of networking and mutual support.

You-Talent Program

The “You-Talent” program facilitated peer advisory groups to help members tackle difficult, but commonly faced problems. Formed by NGO leaders in similar stages of development, the peer advisory group provides a space for leaders to seek input and learn from the experience of others.

May 12th, 2016, the Program held peer advisory group facilitator training events both in Beijing and Shanghai. Fourteen You-Talent members practiced tools for problem solving and peer communication (such as world café) under the guidance of expert peer advisory group trainer, Mr. He, Yongping . In the latter half of the year, the trainees put these tools in practice in facilitating more than 60 organizational events.

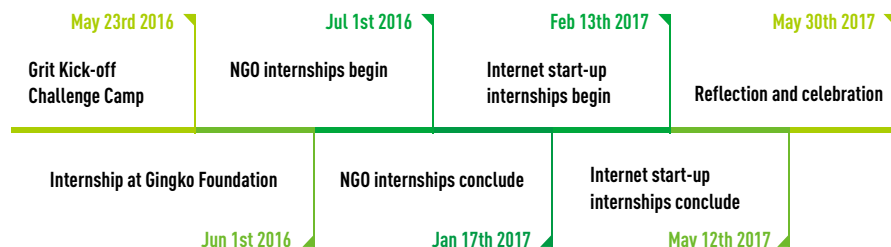

Founded by the Ginkgo Foundation, the Grit Project provides gap-year experiential learning opportunities to youths. With the Project, students dive deep into both the social sector and the world of Internet startups, through which they gain practical knowledge on a range of social issues and achieve valuable personal growth.

Grit Project (Class of 2016) Timeline



Recruitment

Application for Grit Project Class of 2016 began on March 1st 2016. We mobilized members of the wider youth outreach community, including BottleDream, SEED, and PIM, to promote the Project collaboratively.

On March 31st 2016, we received a total of 212 applications. After a comprehensive selection process that included two rounds of interviews, 10 finalists were selected to become the first "Grit Fellows".

Challenge Camp

In the Grit Kick-off Challenge Camp, Grit Fellows spent 10 days in intensive studying, physical exercise, and team building activities. Moreover, they from respected members of the NGO community, including Xiaoyan Liang, Weiguo Zhu, Yongfeng Feng, Dun Li, Xie Yan, Shi yan, as well as trips to NGOs in local migrant worker communities.

Internship at Ginkgo Foundation

In June of 2016, Grit Fellows completed a one-month internship in Ginkgo Foundation, where they were trained in professionalism and developed deeper understandings for the non-profit sector. During this time, they also spent time visiting a number of Ginkgo Foundation's partner NGOs, some of which would later become the host for the next step in their journey.

On January 17th, 2017, the 7-month duration of NGO internship concluded and the Grit Fellows all experienced tremendous personal and professional growth. Gaining empathy and thoughtfulness were probably the most obvious demonstrated. "I took notice of the living condition of hair-washing staff in the salon for the first time, and he was about my age."

One Fellow shared. "When an NGO lacks funding, its members usually choose to sacrifice personal time and healthy life style to sustain projects. NGO work is even more difficult than I had imagined." Self-reflection and a sense of community were also common themes, another Fellow reflected, "When making a decision, it is critical that we consider all the stakeholders." Another observed, "Even when we cannot agree with another person, we can still form a relationship that is mutually beneficial, and not that of opposition or negligence."

Finally, through the Grit Program, we built a partnership network with other organizations that also share the value of service learning, including PEER and Beijing No.4 Highschool Alumni Association Education Promotion Foundation. We strive to continue to promote the value of service learning and we hope that community service becomes a shared learning experience for all young adults.

Community Foundation Pilot Program

In 2016, Ginkgo Foundation conducted the Community Foundation Incubation Pilot Program with support from the Beijing Welfare Lottery Fund and Beijing Municipal Bureau of Civil Affairs. In this program, we used an integrative and multi-stakeholder approach. By engaging collaboration between government officials from multiple levels, scholars, social workers, civil groups and local residences, we facilitated the introduction of a series of Community Foundation management tools.

Activities

The activities we facilitated in this program included “community mapping”, one-on-one mentoring, group discussions, and visits with the community secretary. We also conducted the Beijing Community Foundation Seminar.

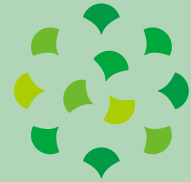

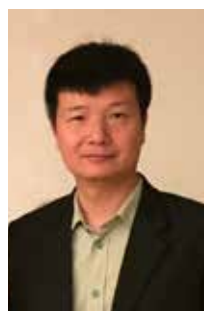
Garrison (Feng) Lu, Director

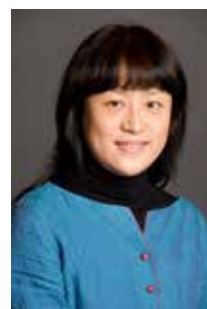
Hong Lin, Director

Ginkgo Foundation is managed collaboratively between the Board of Directors, the Secretariat Team and Ginkgo Fellows.
