
"When the old stories are meltdown, yet new ones have not been formed, how are you going to live in such confusing days?" Yuval Noah Harari precisely captures that today the sense of security is like a bubble, and it would explode once it appears to have reached a stable form. Today we might read promising news about the invention of a vaccine against COVID-19, nevertheless, the next day we might hear the tragedy of a young boy with cerebral palsy dying alone at home because no one can help him at his hour of need. In a fickle, complex and uncertain world, how can we foresee a good society heading to a better future?

Our Response

New social problems are emerging all the time. But the existing solutions only target the symptoms instead of their root causes. The atomization of our society and fragmentation of information makes many people feel more and more isolated as if being trapped on their individual islands, are unable to find a sense of meaning and fulfillment, and afraid to trust others.

Real social changes only come from people's change. Society is akin to land suffering from soil compaction: when the first bulks of grass grow and come together, the soil begins to loosen, allowing the growth of trees and flowers to follow, gradually extending and creating an oasis.

Changemakers with an entrepreneurial spirit are the first seeds to sprout. Regardless of whether they are living under an unjust and unreason situation or providing support to others in an emergent circumstance, they will not stand by and watch. Instead, they devoted themselves wholeheartedly to improve the current situation. The Ginkgo Foundation's strategy is to find such people, to support their actions, and to help them to form a self-organized support community. 
PUBLIC WELFARE SECTOR IN CHINA

DEVELOPMENT OF GINKGO FOUNDATION

1 In 2004, following the issuance of the Regulations on Foundation Administration Foundations⁴, the number of private foundations dramatically increased. Prior to that, most foundations in China were "public foundation", mainly funded by the governments (GONGO). This regulation has changed the landscape of the public welfare sector in China. By the end of 2019, there are 7,628 public and private foundations.



- 2 In 2008, a magnitude 8 earthquake struck Wenchuan County in south-west China. After the earthquake, the total charitable donations in China increased from \$440 million in 2007 to \$16.1 billion–a 30–times increase in one year. For the first time, millions of ordinary Chinese started to participate in charity. A new era started since then.
- 3 China's first national Charity Law was issued and implemented since 2016. The law set up the foundation of a comprehensive system combining the government and industry self-regulation with social supervision in regulating charities.
- 4 In 2017 China's Overseas NGO Law⁵ was issued, and the Government's ability to regulate and supervise the activities of the charity sector strengthened.
- 4 Regulations of the Management of Foundation (2004) were the first national-level regulations specifically focused on the regulation of foundations in China.
- 5 The Overseas NGO law (2017) is China's first law regulating the activities of NGOs in China, who have been founded and are headquartered outside of Mainland China.



- 1 The Narada Foundation was established as a nationwide private grant–making foundation⁶ on May 11th, 2007 with the approval of the Ministry of Civil Affairs of China.
- In 2010, the Narada Foundation launched the Ginkgo Fellow Program to invest in and nurture social entrepreneurs, who are encountering bottlenecks in their career and personal development.
- 3 In 2015, with Ginkgo Fellow Program as its cornerstone program, the Ginkgo Foundation was founded by Ginkgo Fellows, Narada Foundation, Zhejiang Dunhe Foundation, Xinhe Foundation, and Nonprofit Research Center at Renmin University of China, and registered with Bureau of Civil Affairs in Beijing.
- 4 In 2016, the Ginkgo Foundation received an Equivalency Determination certification from NGOsource of the United States, equivalent to a 501(c)(3) qualified organization.

MAJOR EVENTS OF THE FOUNDATION IN 2019

February

The Accenture strategy team helped to draft a 3-year strategic plan for the Ginkgo Foundation pro bono in conjunction with the MindX team.

January

The Ginkgo team moved to a co-working space in East Gate Plaza, enabling a more open and innovative work style.

June

The first Board of Directors successfully handed the power over to the second Board of Directors and approved the first draft of the strategic plan.

May

Cooperated with Ginkgo's partner organization "Aobag Environmental Protection Technology Co." and implemented a waste sorting and recycling practice in East Gate Plaza.

September

Ginkgo Fellows participated in our Overseas Learning Expedition visiting the UK and Germany to get a closeup and systematic understanding of social development and innovation of the two countries

The first joint conference of the Ginkgo Fellow community was held in Guangzhou to promote collaborative work and make a more active community.

November

As the representative of organizations providing training and incubation services to NGOs, the Secretary-General of the Ginkgo Foundation delivered a speech at the opening ceremony of the Charity Convention in Beijing. Her message of nurturing social entrepreneurship was well received by the leaders of the Ministry of Civil Affairs and their peers.

The second Board of Directors convened for the first time and agreed to take an exploratory step in a new strategic direction.

December

The Ginkgo team initiated a discussion on building organizational culture.

March

The Ginkgo Fellow of 2019 Spring Gathering was held in Hainan Province, laying the foundation for subsequent strategic planning and cooperation between the foundation and its partners.

April

Recruiting new cohort of the Ginkgo Changemaker Small Grants Program and approximately 100 applications were received within one month.

June

Ginkgo held Open Day events in Guangzhou and Chengdu, bringing together frontline practitioners from different backgrounds. These events helped frontline practitioners and the foundation to get a better understanding of each other's work and develop a stronger connection.

The campaign "Guarding the Green Peacock with Art" was held in Beijing with Ginkgo's partner organization Friends of Nature and origami artist Liu Tong.

July

The first of Ginkgo's Domestic Learning Expeditions held. This included visits to the Cross-border Environmental Concern Association, zerowaste villages, and the Village Alliance of Southeast Guizhou and Guangxi. These visits help young changemakers to get a deeper understanding of different sustainable development models in local communities.

November

The Social Innovation Pop-up Event was held in Xi'an⁸ to provide young people with the opportunity to hear stories from social entrepreneurs at different stages of development and to understand their challenges and thinking.

Nine social entrepreneurs were selected as the 2019 cohort of Ginkgo Fellows.

The Ginkgo Fellows Fall Gathering was held in Xi'an. In the forum Fellows exchanged how their work contributed to the China society under the framework of United Nations Sustainable Development Goals (SDGs).

December

Two training sessions for peer advisory group facilitators (TOTs) were successfully completed. This year the members not only made breakthroughs in their own development journey but also carried out private board advisory activities in their teams and communities.

Journal of On-site Interviews

After a day and a half in Chengdu in the heat of July, we headed to our next stop - Lhasa⁹. During these 4 days in Lhasa, in addition to visiting the candidates, we also met with three other NPO partners, hoping to learn as much as possible about the frontline stories and look for possibilities for collaboration in the limited time we had. Our last stop was Qinghai¹⁰, the vast Tibetan plateau which is more than 4,000 meters above sea level. We spent 14 hours covering three communities in the space of

one day. It is more than a two-hour drive from one community to another. Throughout the process, we were in constant discussions with the candidates and the team, learning their stories and gathering information based on the reality of their situation.

This is a snapshot of the Ginkgo Fellow Program's fieldwork.

Program Introduction

Many of the challenges in today's society are so complex that they cannot be solved by individuals or single organizations alone. Since the root cause of problems is often structural, the key to solving them lies in coordination with various social actors and reconciling different interests and values. This requires "network leadership", which is the focus of the Ginkgo Foundation's "Community-Based Learning" section.

"Community-based learning" focuses on individual growth and learning. By "community", we mean a community of changemakers with a social entrepreneurial spirit. The changemakers in the community all have diversified identities, traits, concerns, and interests. Such communities place greater emphasis on not communicating authoritatively, but as equals in a non-hierarchical fashion. Through shared learning, communities can develop continuously and enhance their thinking and action to better respond to urgent problems and external changes. Communities are not closed or fixed, but open, flexible, diverse, rich and constantly evolving collectively. By creating various learning scenarios, we hope each changemaker can heighten one's holistic view, empathy, and the ability to collaborate with others. Thus, to improve their leadership of the "community" and bring systemic change.

COMMUNITY-BASED LEARNING

Overseas Learning Expedition

With eight years of support from the Xinhe Foundation, Ginkgo Fellows have always treated the Overseas Learning Expedition as an important learning opportunity. The Foundation and Ginkgo Fellows have also set up a learning circle which has helped participants to develop their collaboration and problem-solving skills.

The 2019 Ginkgo fellows chose to visit the UK and Germany once again.

What struck the Fellows the most during their visit to the UK was the relationship among the government, market, and the social organization. The three sectors have different boundaries of responsibility and operational principles when they address various social issues. Because of the technology development, the boundaries among these three sectors have been gradually blurred and some hybrid organizations emerged.

The Fellows who visited Germany found that deep reflection is embedded in the DNA of German society and its citizens. When the Berlin Wall fell, the entire world paid attention to the integration of East and West Germany. Now, Germany faces a new round of challenges: in approximately three years, Germany has received 1.5 million refugees. Civic engagement is becoming the core of social innovation in Germany.

Domestic Learning Expedition

In 2019, we launched a new communitybased learning program—the Domestic Learning Expedition-which brought together young changemakers to learn together for seven days. During the time, they visited 3 different organizations associated with Ginkgo Fellows. This year, the three sites visited were the coastal wetland in Dongguan¹¹, zero-waste Villages in Dongyang County of Jiangxi Province, and the Village Alliance of Southeast Guizhou and Guangxi Province. Teams in these places work on a range of issues including wetland protection, rural waste disposal and recycling, cultural protection, and community development. Our visits focused on how local teams making better use of local resources, joining forces and collaborating with stakeholders, and empowering local communities to form their own networks. This is all to enable greater impact in tackling the issues at hand.





Facilitator Training for Peer Advisory Group

Peer advisory group or peer board is a set group of peers with the same or similar background, who under the guidance of a facilitator inspire each other to challenge their traditional mindset and help to solve practical problems encountered by group members. At the Ginkgo Foundation, we pay attention to peer board facilitator training: Ginkgo fellows can develop their leadership of peer boards by forming peer advisory groups.

With continued funding from Dunhe Foundation, the 2019 Facilitator Training for the Peer Advisory Board recruited a total of 14 highly motivated Ginkgo Fellows and conducted two five-day training sessions in June and December respectively. The satisfaction rate was 95%. 90% of the Fellows applied peer board techniques in institutional meetings, team capacity development, etc., and each trainee carried out an average of two of their own peer board meetings.

The Important Role Played by the Ginkgo Fellow Board Members

In June 2019 with the formal succession of the second Board of Directors, four Ginkgo Fellow board members began to collect feedback from the Ginkgo Fellow community to provide more comprehensive input into Board's decision-making process, while also relaying important messages from the Board to the Fellows.

More Community Groups Emerged with the Support of the Fellow Committee

Many groups have sprung up spontaneously within the community, including 8 community groups such as the Overseas Learning Expedition Support Group, the Convention Group, and the Experience Group of Multicultural Heritage. Fellows from a community can get to know each other and discuss specific topics in groups. Therefore, they can connect with each other and then provide better and more efficient support for each other.



Application Numbers to the Collaboration Fund Project Reached a Record High

Since 2015, a "Collaboration Fund" has been established within the Ginkgo Fellow community to encourage exchange and cooperation among Fellows. The 2019 Collaboration Fund team focused its work on promoting cooperation and innovation among Fellows. This included using a variety of approaches such as project demonstrations, workshops, which has attracted more Fellows to initiate cooperation projects. In the Spring of 2019 applications for 20 projects

were submitted from 57 different participants. Project funding of \$110,000 was applied for in total, double that of 2017 with 11 projects granted approval. The Collaboration Fund team held 4 on–site working meetings throughout the year to review its operations and defined its roles more clearly: observer, participant, and monitor.





A Collaboration Fund Fellow's Story

I am a 2018 Ginkgo Fellow. I was not eligible to apply for the Collaboration Fund until the Spring Gather event in 2019. Once we met in 2019, I rushed to apply for the Collaboration Fund with Qi Lixia, a Fellow of 2012.

I grew up a left-behind child¹², and I also worked as an educator for children of migrant workers. I founded the Science Tadpole and Shiwu Academy. Qi Lixia, a former migrant worker¹³ and the "Mother of Left-behind Children" worked at the Women Migrant Workers' Community Service Center and founded the Magnolia Blossom. Our collaborative project is the "Museum of Female"

Migrant Workers' Stories", which organizes college students and female migrant workers to write stories about their experiences and then curate exhibitions together.

With such participation, I have become more open to the projects in the Collaboration Fund. I can understand that these collaborations may provide many benefits for everyone. It has helped to collaborate with others, promotes mutual understandings, reach a consensus, and generate new ideas and actions.

Social Innovation Pop-up Events

Social Innovation Pop-up Events are brand communication activities initiated by the Ginkgo Foundation. Through TED-like public speeches and art exhibitions, we hope to provide the public with a more vivid experience of what social innovation and non-profit activities are about. The third Social Innovation Pop-up Event of 2019, themed "cloud power" was held in Xi'an, and 9 social entrepreneurs shared powerful stories on relevant topics. We also openly recruited 15 young artists, who focus on social issues, to participate in the exhibition and share their work, including photography, paintings, installation art, digital art, and physical performance art among other forms. Over 300 people attended this event, and the live broadcast platform provided by ifeng. com¹⁴ was viewed by 134,000 people.

Joint Campaigns

Public Advocacy for Green Peacock Protection

In 2019, the Ginkgo Foundation organized and held the launch event of "Guarding the Green Peacock with Art" campaign in Beijing. The number of online participants reached 404,000. Following this, a range of parties came together to launch the "Fold 500 Paper Green Peacocks for the Last 500 Green *Peacocks*" social media campaign on Weibo¹⁵, which was viewed over 7 million times in 10 days and prompted 14,000 online discussions on this topic. The campaign ran for nearly a month reaching around 55 million people.

Over the past three years, our partnered organization Friends of Nature has continued to promote green peacock conservation through lawsuits, public participation, scientific education and other efforts. Good news finally came in early 2020, when a verdict was reached in China's first preventive public welfare lawsuit relating to wildlife protection. The Green Peacock Protection Case was filed by Friends of Nature, and the court called for an end to projects which cause destruction to green peacocks'habitats. Efforts to protect the green peacock will continue.

北京市银杏公益基金会:

一、审计意见

我们审计了北京市银杏公益基金会(以下简称银杏基金会)的财务报表,包括2019年12月31日的资产负债表,2019年度的业务活动表和现金流量表以及财务报表附注。

我们认为,后附的财务报表在所有重大方面按照《民间非营利组织会计制度》的规定编制,公允反映了银杏基金会2019年12月31日的财务状况以及2019年度的经营成果和现金流量。

二、形成审计意见的基础

我们按照中国注册会计师审计准则的规定执行了审计工作。审计报告的"注册会计师 对财务报表审计的责任"部分进一步阐述了我们在这些准则下的责任。按照中国注册会计 师职业道德守则,我们独立于银杏基金会,并履行了职业道德方面的其他责任。我们相信, 我们获取的审计证据是充分、适当的,为发表审计意见提供了基础。

三、管理层和治理层对财务报表的责任

银杏基金会管理层(以下简称管理层)负责按照《民间非营利组织会计制度》的规定 编制财务报表,使其实现公允反映,并设计、执行和维护必要的内部控制,以使财务报表 不存在由于舞弊或错误导致的重大错报。

在编制财务报表时,管理层负责评估银杏基金会的持续经营能力,披露与持续经营相关的事项(如适用),并运用持续经营假设,除非管理层计划清算银杏基金会、终止运营或别无其他现实的选择。治理层负责监督银杏基金会的财务报告过程。

四、注册会计师对财务报表审计的责任

我们的目标是对财务报表整体是否不存在由于舞弊或错误导致的重大错报获取合理保证,并出具包含审计意见的审计报告。合理保证是高水平的保证,但并不能保证按照审计准则执行的审计在某一重大错报存在时总能发现。错报可能由舞弊或错误所导致,如果合理预期错报单独或汇总起来可能影响财务报表使用者依据财务报表作出的经济决策,则通常认为错报是重大的。在按照审计准则执行审计的过程中,我们运用职业判断,并保持职业怀疑。同时,我们也执行以下工作:

- (1)识别和评估由于舞弊或错误导致的财务报表重大错报风险;设计和实施审计程序以应对这些风险,并获取充分、适当的审计证据,作为发表审计意见的基础。由于舞弊可能涉及串通、伪造、故意遗漏、虚假陈述或凌驾于内部控制之上,未能发现由于舞弊导致的重大错报的风险高于未能发现由于错误导致的重大错报的风险。
- (2)了解与审计相关的内部控制,以设计恰当的审计程序,但目的并非对内部控制的 有效性发表意见。
 - (3) 评价管理层选用会计政策的恰当性和作出会计估计及相关披露的合理性。
- (4)对管理层使用持续经营假设的恰当性得出结论。同时,根据获取的审计证据,就可能导致对银杏基金会持续经营能力产生重大疑虑的事项或情况是否存在重大不确定性得出结论。如果我们得出结论认为存在重大不确定性,审计准则要求我们在审计报告中提请报表使用者注意财务报表中的相关披露;如果披露不充分,我们应当发表非无保留意见。我们的结论基于截至审计报告日可获得的信息。然而,未来的事项或情况可能导致银杏基金会不能持续经营。
- (5) 评价财务报表的总体列报、结构和内容(包括披露),并评价财务报表是否公允反映相关交易和事项。

我们与治理层就计划的审计范围、时间安排和重大审计发现等事项进行沟通,包括沟通我们在审计中识别出的值得关注的内部控制缺陷。




