HONORARY BOARD CHAIR

ZHAO Yilan



The shadow cast by the pandemic has followed society through 2021, and the highly contagious Omicron variant has posed a great challenge to the country's zero-infection policy. It has also been difficult to strike a reliable balance between overcoming the pandemic and maintaining economic growth and social normalization.

At the same time, we are also facing the challenge of an uncertain economic outlook. In the troika of GDP investment, consumption, and exports, dividend persistence from exports remains uncertain as a result of the evolution of the pandemic in different countries, while investment suffers from the double impact of local debt and real estate crises. Industries such as entertainment. Internet finance. education and training, real estate, and infrastructure have all come under pressure, which led to salary cuts and unemployment. Household income growth has been weak, leading to sluggish consumption.

This year saw the persistence of sharp international competition and confrontation abroad, and extreme climate change episodes at home. All of these factors have filled our living environment with challenges and risks. Winter has come, but spring is still far away.

The drastic changes both internal and external have resulted in increasing social problems and solving them would require much more strength and collaboration. This year, the Ginkgo Foundation and more than 139 social

entrepreneurs have focused on social issues and driven by action. Our support and companionship have allowed social entrepreneurs and their teams to safeguard, trust, and help each other. The changes they have implemented occurred in different fields. including-ecological environmental protection, education, traditional culture conservation, and talent support in public welfare, across different regions-villages and cities, islands and inland-and have helped disabled groups, migrant women workers, left-behind children, among other precious, ordinary lives.

Fortunately, we are moving forward with a growing number of partners with a sense of mission and goodwill. While continuing to support Ginkgo Fellows, we have also been able to support several young social actors and their communities, who are the seeds of social entrepreneurship. Through collaborations with photographer Andrew Wong and TEDxGuangzhou that employed a range of mediums such as photography, podcast, and non-fiction writing, we partnered with professionals in different fields to tell more stories of social entrepreneurs to the public and inspire more people to work together to make change happen.

From our perspective, social innovation and the public welfare industry will face dual challenges in the future: both internal and external distress will make it more difficult for resources to flow into this field, and changes in the regulatory environment will greatly challenge the operational efficiency of these organizations. How will we be able to obtain more resources through social innovation? How should we use the means of technological progress to enhance our action and influence? These will be major issues for discussion in the future. To better cope with external changes, the Ginkgo Foundation is also making positive adjustments. We cherish you who have been with Ginkgo on this journey. We will continue to embrace more surprises and innovations, and actively seek breakthroughs in changes.

Times are changing, but what remains grounded is our mission and vision. We are always seeking, connecting, and inspiring young activists with the spirit of social entrepreneurship, working with them to come up with solutions to social problems, and together, making a joint impact. In the new year, I hope you will work with us and inspire everyone to live with the freedom of choice and dignity, and to create a diverse and inclusive society.

Ginkgo Foundation entered its 11th year in 2021. This was also the year that marked the changing of the guards from the old to the new team of the foundation. The board chair and first secretary-general of Ginkgo Foundation, LIN Hong, has departed from Ginkgo and began her new journey in entrepreneurship. I am now holding a concurrent position as the board chair of Ginkgo and representative of Narada Foundation, founding organization and sponsor of the Ginkgo Foundation. We also welcomed our new secretary-general, Ginkgo Fellow ZHANG Boju, to the foundation at the end of the year.

At such a time, it is ever more important for the foundation to remind ourselves of its founding mission and to look forward into the future.

The Ginkgo Foundation was born out of the Ginkgo Fellow Growth Projec initiated by the Narada Foundation in 2010. As a foundation dedicated to supporting social organizations and public welfare, Narada realized that an important factor restricting the development of China's public welfare sector at that time was the limitations posed on talent. Narada developed and launched the Ginkgo Plan, hoping to drive the development of their organizations and the entire sector by supporting the founders and principals of outstanding social organizations.

In the past 11 years, the Ginkgo Project (and later, the Ginkgo Foundation) has selected and funded 139 Ginkgo Fellows based on the principles of "globally-minded, down-to-earth, and the spirit of entrepreneurship". As an individual, each partner assumes the responsibility of leading their team to realize the mission of their organization and drive social solutions. Many Ginkgo Fellows have achieved numerous cases of success in this regard.

However, as a group, what kind of responsibilities should Ginkgo partners take? This requires more indepth consideration and discussion by Ginkgo Fellows and the Ginkgo Foundation. Has the group of Ginkgo Fellows utilized their due ability and potential in the past? Have they achieved the effect of "one plus one is greater than two"? Could Ginkgo Fellows make a greater contribution to their issues, regions, and even the entire sector? Ginkgo Fellows, as outstanding individuals in the public welfare sector, have received funding, capacity, and social network support from the Ginkgo platform. Individuals and organizations that have supported Ginkgo Fellows have high hopes for this community, aspiring for Fellows to do more for the public welfare sector as a group and push for sectoral development.

Ginkgo Fellows and Ginkgo Foundation should not only look within the Ginkgo community, but to also look outward and pay closer attention to issues outside of their own organizations and the Ginkgo community. At the same time, Ginkgo Fellows also require more collaboration, whether

in terms of the work on their issues regions, or in other matters in the sector. For example, when the COVID-19 pandemic broke out in early 2020, nearly 20 Ginkgo Fellows quickly assembled for pandemic relief efforts. It was a great example of how Ginkgo Fellows proactively looked outwards, cooperated effectively, wielded their collective power, and transcended individual responsibility.

The stories of individuals are closely linked with the story of the times China and the world are undergoing profound changes unprecedented in a century. Profound changes are taking place in the world order, in scientific and technological revolution, and in human and social dimensions. In such an era, it is particularly necessary to reflect on and examine the responsibilities of Ginkgo Fellows.

We hope that Ginkgo Fellows will continue to surpass themselvesto see our individual and group responsibilities in this critical time; to transcend beyond the ego and see a larger picture. I hope that the Ginkgo Foundation can actively connect with our colleagues in the field in wider and deeper ways, stand its ground on the soil of China, and explore new opportunities and mechanisms to support Ginkgo Fellows and ever-more downto-earth, globally-minded social entrepreneurs responding to social needs and challenges. In 2021, the Ginkgo Foundation supported the personal growth and development of social entrepreneurs and organizational innovations through Ginkgo Fellow Growth Project, Breakthrough Project, Collaboration Fund, and other projects, assisting them in the breakthrough and transformation of their careers and accompanying them in their work on social solutions and creating social value. A total of 44 projects were funded this year, covering areas such as poverty alleviation, support for the elderly and young, community development, high-quality education, disaster reduction, disaster prevention and relief, biological and environmental protection, and addressing climate change.

Through the form of trust grants, while supporting our partners, the Ginkgo Foundation is also deeply engaged with an understanding of their values, capabilities, strategies, management systems and trend analysis, cooperating with and exploring alongside our partners to create a joint impact.



Since the project's launch in 2018, the Ginkgo Foundation has adopted the DAF (donor-advised fund, in which donors can participate in decision-making with the support of professionals, in addition to monetary donation) funding model to help Ginkgo Fellows and their organizations achieve innovations and breakthroughs . The average amount of individual funding is RMB 100,000, which is mainly used for research and development, pilot projects, and project upgrades.

As of the end of 2021, the Breakthrough Project had carried out 7 phases of funding (4 phases of innovative key projects, 2 phases of scholarships, and 1 phase of pandemic relief), supporting 38 projects, including 28 innovative key projects, 7 pandemic relief projects, and provided scholarships for



The Breakthrough Project gave 12 partner institutions the opportunity to experiment with breakthrough innovations. Based on the analysis of completed projects, 20% of partners were provided with more sufficient resources

and space to explore new businesses and to promote business development, organization, and core personnel transformation; 66% of partners were able to achieve innovation in existing work areas, test new ideas and create new paradigms for social solutions, and improve the ability of social entrepreneurs and their team members to implement social solutions.

In 2021, the Ginkgo Foundation supported the steady, independent development of the Ginkgo Fellow community, the SEED for Social Innovation community (referred to as "SEED"), the Guangzhou Shandao Social Work Service Center (referred to as "Shandao") collaborator community, among others.

This year marked a big step forward for the independent development of the Ginkgo Fellow community. The 9th Ginkgo Fellow Committee put forward the plan for overall community development for the first time, including the New Plan for Ginkgo Fellow Recruitment led by Ginkgo Fellows for the independent selection of fellows, the Fasheng Project to support the growth of community members, and the Regional Development Plan to expand community impact and improve sector environment, etc.

Through the Happening Project, the community funded 2 social entrepreneurs growth support projects, allowing partners to connect independently, support each other, and achieve growth; the Regional Development Plan funded 2 regional public welfare sector development projects to promote the possibility of the development of the public welfare sector in the Northeast and Jiangxi province. This marked an important milestone of the independence, autonomy, and influence of the Ginkgo Fellow community.

The Ginkgo Foundation funded the Ginkgo Fellow Community Development Program and supported the development of the Ginkgo Fellow community by sharing past experience, following closely the exploration of various community groups, and promoting communication and collaboration among groups.

Plan for Ginkgo Fellow Recruitment and established a new work group. 



In 2021, the Ginkgo Foundation channeled the spirit of social entrepreneurship through a more effective public narrative and focus on building a joint impact.

In August, the project "Seeing Them in Action", which documented the real stories of activists, was launched. Based on social entrepreneurs and their communities, the project featured non-fiction accounts of how these talented social entrepreneurs identified social problems and had the courage to take action in helping to solve these problems. The articles published under this project include "Love Without Limits, the Birth of a LGBTQ Documentary", "How a Group of People Who Want to Change the World Plan to Take Care of Their Own Health", "How to Build a System That Will Allow Us to Age with Dignity?" and "Turn the Tide on the Derailed Lives of Children from Remote Areas", covering issues that range from gender diversity, senior care, and education for left-behind children, to self-care for professionals in the non-profit sector. The articles were shared by Ginkgo Foundation's partner institutions and industry media outlets.

One of the Ginkgo Foundation's current efforts is to explore new ways to promote the spirit of social entrepreneurship through photo stories, podcasts, and other formats that will make the narratives of entrepreneurship come alive and reach a wider youth community. "FAYA TALK", a WeChat public account under the Gingko Foundation's official account, is a platform that focuses on social issues and

stories, allowing the public to follow and discuss social and public issues through articles, talks, podcasts, and other content. Co-produced with TEDxGuangzhou programmer Jimmy, the podcast "My FAYA Story" was launched this year, in which social entrepreneurs were invited to tell their own stories. A total of 12 podcast episodes were produced and released on podcast platforms including Himalaya and Xiaoyuzhou. Among them, the 8th episode "The Origins of Teaching Rural Children to Write Poetry—KANG Yu" was featured on the front page of Himalaya.

The "Uncommon Common People" project is the Ginkgo Foundation's experiment with storytelling through photography. Following the exhibition tour in Beijing, Xi'an, Lanzhou, and other cities in 2020, in May 2021, the "Uncommon Common People" photography exhibition was unveiled at Tencent's Internet Good Summit in Chongging. The heart-felt and genuine presentation attracted the attention from across the public welfare sector. In October and November 2021, the Ginkgo Foundation continued our collaboration with photographer Andrew Wong to visit Jiangmen in Guangdong and Wuding county in Yunnan to photograph Ginkgo Fellows LIANG Jianling and LI Jun, capturing moments from their work and life.

The RE·NEW conference is an industry conference co-sponsored by the Ginkgo Foundation and the SEED Social Innovation community. "RE·NEW" carries the meaning of "to make new again", which points to both empowerment and rebirth. Through these innovative events, the Ginkgo Foundation hopes to bring together entrepreneurs and social actors from different regions and areas of focus to explore the possibilities of innovative practices and collaborative solutions to social problems. Due to the effects of the pandemic, the event originally planned for November this year has been postponed to 2022.



HOW GINKGO FOUNDATION PUSHED FOR SOCIAL CHANGE



The Ginkgo Foundation has always focused on the accumulation of action knowledge, and to share and pass on our experiences. Beginning in 2020, the Ginkgo Foundation systematically evaluated the practices of the Ginkgo Fellow Growth Program, and proposed a path for "investing in people" with the aim to promote systemic social change—to support a social entrepreneurially-minded community and their leadership through building network leadership, so that they may nourish and strengthen one another, and ultimately, through cultivating and practicing their joint impact, form a common vision with the motivation and ability to jointly push forward systemic changes.

Since the pandemic in early 2020, many non-profit organizations and individuals have united in the work of pandemic relief. Based on the discovery of a number of differences between this pandemic relief and previous disaster relief efforts in the process of participating and supporting these efforts, the Ginkgo Foundation organized our partners and their teams, young researchers, and academic experts to conduct special research in this area. This research adopted a "bottom-up" approach, granting agency to participants, identifying them in the role of researchers, and providing them with research funding, research methods, and collaborative research support. Consensus among the group is required for all research results to finalize, which also provided points of reference for future actions.



Research Report on Social Participation in Combating Pandemic and Disaster Relief Actions Author: TAO Chuanjin

The Ginkgo Foundation supported a group of activists and researchers to form an action research team. After 2 years of continuous research, participation, and indepth discussions, the Ginkgo Foundation summarized the experience of social organizations that participated in major events in the fight against the pandemic, and released a compilation of case studies titled "We Are In Action". The "Research Report on Social Participation in Combating Pandemic and Disaster Relief Actions" analyzed social organizations and social development from multiple angles and proposed that the functions of social organizations in combatting pandemic and disaster relief were divided into: (1) fundraising and delivery of supplies; (2) the provision of specific social service systems and a humanistic atmosphere; (3) participation in community governance systems to avoid overly rigid control; (4) the effects of becoming an intentional social agent inspired by one's own participation.

北京市银杏公益基金会:

一.审计意见

我们审计了北京市银杏公益基金会(以下简称银杏基金 会)的财务报表,包括2021年12月31日的资产负债表, 2021年度的业务活动表和现金流量表以及财务报表附注。

我们认为,后附的财务报表在所有重大方面按照《民间 非营利组织会计制度》的规定编制,公允反映了银杏基金 会2021年12月31日的财务状况以及2021年度的经营成果和 现金流量。

二.形成审计意见的基础

我们按照中国注册会计师审计准则的规定执行了审计工 作。审计报告的"注册会计师对财务报表审计的责任"部分 进一步阐述了我们在这些准则下的责任。按照中国注册会 计师职业道德守则,我们独立于银杏基金会,并履行了职 业道德方面的其他责任。我们相信, 我们获取的审计证据

决策,则通常认为错报是重大的。在按照审计准则执行审 计的过程中,我们运用职业判断,并保持职业怀疑。同 时,我们也执行以下工作:

银杏基金会管理层(以下简称管理层)负责按照《民间 非营利组织会计制度》的规定编制财务报表, 使其实现公 允反映,并设计、执行和维护必要的内部控制,以使财务 报表不存在由于舞弊或错误导致的重大错报。

在编制财务报表时,管理层负责评估银杏基金会的持续 经营能力,披露与持续经营相关的事项(如适用),并运 用持续经营假设,除非管理层计划清算银杏基金会、终止 运营或别无其他现实的选择。治理层负责监督银杏基金会 的财务报告过程。

四.注册会计师对财务报表审计的责任

我们的目标是对财务报表整体是否不存在由于舞弊或错 误导致的重大错报获取合理保证, 并出具包含审计意见的 审计报告。合理保证是高水平的保证, 但并不能保证按照 审计准则执行的审计在某一重大错报存在时总能发现。错 报可能由舞弊或错误所导致,如果合理预期错报单独或汇 总起来可能影响财务报表使用者依据财务报表作出的经济
